1. Report(s) and Pricing. This Order Form is for one or more reports from the ARC SMART Report suite. These are standard ARC reports, and there is no additional customization available, unless mutually agreed by the parties. This Order Form is subject to the provisions of the ARC COMPASS Report Agreement dated [redacted] between ARC and Carrier (the "Agreement"). The Report description and subscription price are as follows:

Standard Report Pricing: A monthly subscription of a single report is \$550 per month on CD-ROM and \$580 per month on paper. Report subscriptions can be packaged (two or more different reports delivered to the same recipient) for a base price of \$725 per month plus an additional fee per report selected as listed below.
