Travel Agency Mailing Labels

The Airlines Reporting Corporation's list of accredited travel agency locations is updated on a daily basis. Such frequency assures you of receiving the most complete and up-to-date listing of United States travel agency locations in today's marketplace. ARC averages between 900 and 3000 updates (adds, changes, and deletes) per month. Each label contains the trade name and address of the agency locations. Owner/Manager names are not maintained.

The type of label offered is **Laser**.

- Laser labels are peel-and-stick, 30 labels per sheet (three across, ten down).

After making your selections, return this completed form along with your check made payable to the Airlines Reporting Corporation. ARC will expedite your order within two working days of the order's receipt date for a \$50.00 minimum charge or 10% of the total order (whichever total is greater).

4. Zip Code Selection

By listing the first three digits of the zip code ranges, you will receive labels for all agency locations which have zip codes in those ranges. For example, if you select ranges 051-053 and 147, you will receive labels in the zip code ranges 05100 through 05399 and 14700 through 14799. You must, however pay for the entire state(s) in which the zip codes are located (See Section 2 - State Selection above). For example, if you want agents in northern Virginia, you will be charged \$36.00 for the 455 agents in Virginia and then ARC will eliminate those labels not in the selected zip code ranges.
